- **Perinatal Doppler and vascular imagery**
- **Advances in fetal echocardiography**

ROLE DESCRIPTION

Summary	ISUOG is committed to building a library of high-quality, didactic “learning modules” based on recordings from ISUOG Advanced Education Courses, supported by the Online Education Content Task Force who oversee the content made available on the ISUOG website. In order to monitor and maintain the quality of the learning modules, a Working Group is required to review lecture recordings from ISUOG Advanced Courses as they take place and suggest any improvements necessary. In order to turn the lecture recordings into interactive learning activities, reviews will also be asked to draft learning objectives and multiple choice assessment questions for this material, and approve its upload to the ISUOG website.
Responsibilities	<p>To work closely with the Task Force chair and the secretariat to:</p> <ul style="list-style-type: none"> • Review video lectures from selected ISUOG Advanced Courses before their general release (2 reviewers will be assigned to each course, with a maximum workload of one course every 2-3 months) • Suggest any changes to be made to the video files • Draft 3 learning objectives and 3-5 multiple choice assessment questions for each video • Approve videos to be uploaded to the ISUOG Learning Modules page
